# Higher capacity for refrigerants Westfalen Group opens plant in Münster-Gelmer

With the opening of a new plant in Münster-Gelmer, the Westfalen Group has expanded its capacities and enlarged its product portfolio with an investment of around 20 million euros. The new filling and logistics site for gases was recently successfully commissioned after 15 months of construction; final construction work on the traffic route has now been completed. Significant parts of the plant's operations, which were previously located at the Münster-Gremmendorf plant, have found a new home here.

The filling and recycling of flammable and non-flammable refrigerants now takes place on the plant site of approx. 100,000 m<sup>2</sup> near the Dortmund-Ems Canal. In addition to handling hubs for acetylene and liquefied gas, the site also includes a warehouse for technical gases, bundle construction, as well as electrical and central workshops. Safety on the plant site is ensured by automatic fire extinguishing systems, catch basins, special storage facilities for technical gases and underground tanks.

"With the opening of the plant, we have expanded our gas capacities and can now offer our customers a larger product portfolio", says a

delighted Dr Meike Schäffler, member of Westfalen's executive board. "Especially for refrigerants and specialty gases as well as in the area of individually manufactured mixtures we are hereby opening up to new markets." By filling and processing flammable refrigerants, the Westfalen Group is actively promoting the change from classic refrigerants, socalled hydrochlorofluorocarbons, to more climate-friendly - in some cases flammable - alternatives.

## Opportunities for urban district development in Münster-Gremmendorf

The relocation of the site has enabled the Westfalen Group to open up the entire Gremmendorf plant area of around 112,000 m<sup>2</sup> for alternative use, providing new opportunities for the development of this district. The sale to the city of Münster and Vivawest GmbH from Gelsenkirchen will enable the construction of apartments and a secondary school.

The commercial vehicle workshop originally located in Gremmendorf has now moved to a new building at the Hörstel (near Osnabrück) plant. By building the new plant in Münster-Gelmer and in Hörstel, the Westfalen Group now is able to implement sustainable growth and increased production efficiency.
