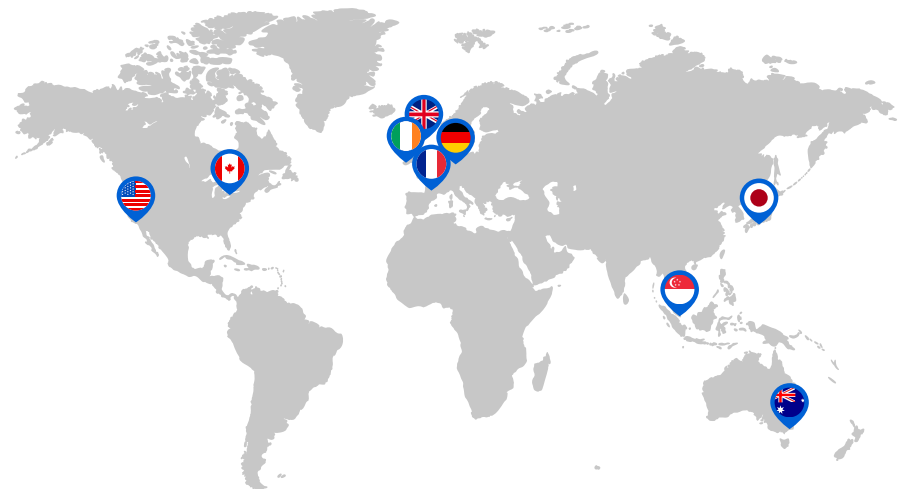

Set up Box Zones in 3 easy steps:

- 2 Map users to a Zone. Users not assigned to a selected Zone will be assigned to the default Zone.
- 3 Change assigned Zone for users at any time. Relevant content is automatically migrated.
