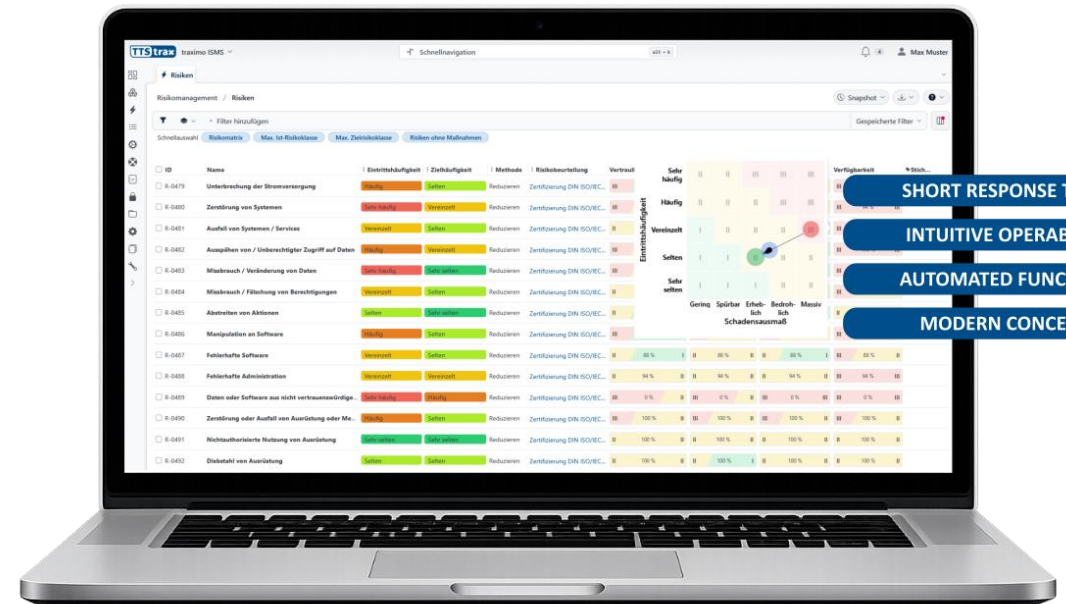

Protection requirement classes, probability of occurrence and risk matrix freely configurable

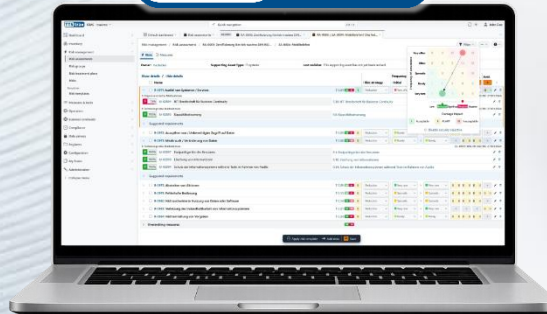


Threat & measure catalogs

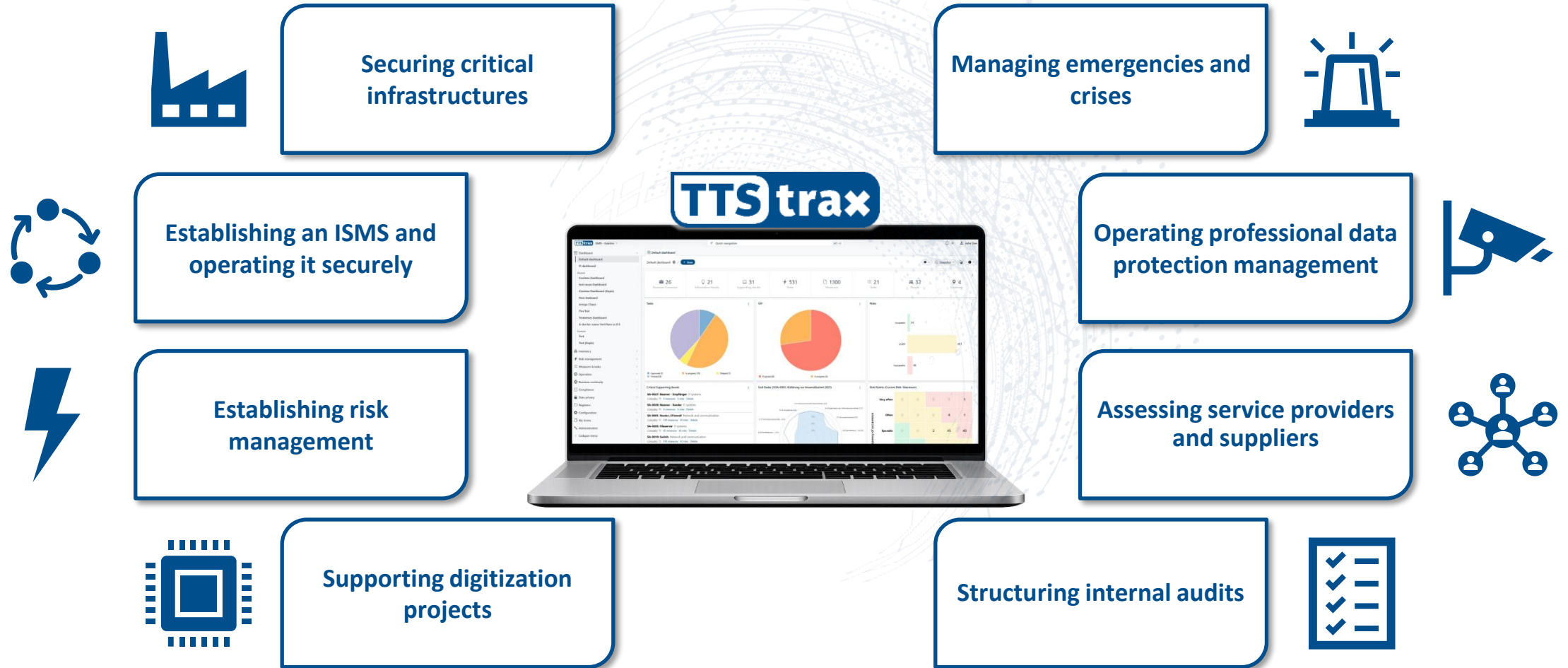

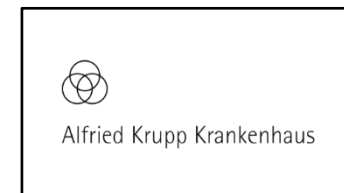
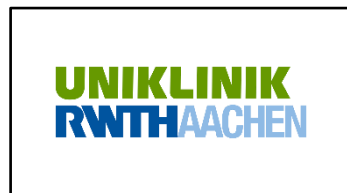
