This is naturally true for fighting ticks and fleas as well. Should one successfully prevent these bloodsuckers to settle on one's pets, then we have achieved a giant leap for preserving our health.

These were the thoughts driving us when collaborating with Szent István Veterinary University and Budapest Technical University, we have developed the Dr Pet tick and flea repellent product line, that provides outstanding protection against external parasites for cats and dogs.

Following years of R&D the Dr Peticon dimethicone-based products were introduced.

Our own Dr Peticon branded products (dimethicone product line) is exempt from the EU biocid regulation due its physical working method (handled as trap).

Collars and topical spot-ons provide general protection, while spray secures a short term but intensive protection that is indispensable during excursions in the woods or walks in the park.

Should the trouble already has happened, shampoo could even be of a help for us and can make your companion animal's everyday comfortable again.

We therefore recommend combined usage of our products, so that we do not even give a chance to the attack of the bloodsuckers.

About us – key facts

- Both of the two owners have over 25 years experience in the pet industry
- Our company was registered in Hungary in 2011
- Few years of preparation and a lot of background processes followed (registrations, certificates, lab tests, etc.)
- Our own biocide product line, Dr. Pet was marketed in 2013
- Our non-biocide product line, Dr. Peticon reached production in 2019

Private label / Store brand

We, as OEM manufacturer are your partner if you plan to use your own label / store brand. We try to keep our business procedures simple and we offer you an effective, win-win long term cooperation as we prefer to have long term business relationships with our partners.

Our key points are:

- Same conditions, MoQ as our own brands
- Same pricing as our products
- We have private label / store label experience

Minimum order requirements

Please understand that we are manufacturer and we have minimum quantities we can produce economically because of some requirements (both legal and cost effectiveness).

We manufacture everything on order, this way you have the maximum shelf life and you get fresh products every time you place us an order.

In general we ask you to order minimum one palette of goods because of manufacturing related general costs and actually smaller quantity might have also per product definitive much higher shipping cost. Our general load on

one palette are 9 rows of cartons, 43 cartons (12 product) per row. We can load up the palette to 12 rows high and because in general there is no shipping cost difference if the palette is loaded up to 9 or 12 rows of products, with the higher palette (more products) you can save on the per piece shipping cost (your profit marge).

We need to have detailed data on every batch we produce, which means that we need to know and store all data on every single shipment we make.

We produce every single order fresh for the exact order, because of the above and because we would like to offer you the maximum shelf time (beside fulfilling the legally required steps towards data monitoring).

We have a minimum, optimal batch size based on the manufacturing process and on the cost effectivity. This determinates the size of the minimum requested size of the batches we make.



On the other side we look to work with partners, who are thinking on a sales network instead on one single shop. We as manufacturer, can offer you manufacturer's price and actually you can use higher profit rate, than usual on the market with this advantage.

We have our collars and spot-ons in cartons, where we have 12 pieces from those in one carton. In general we have a minimum order quantity of 86 cartons (12 products each, 1.032 products in total) on collars and spot-ons per color and per size.



Our Shampoo is packed per 10 unit and we have the minimum order quantity at 1000 bottles (100 packs).

At the sprays we have a carton with 80 bottles and we have 13 boxes (1.040 bottles) as minimum order quantity.

Please understand that these minimum requirements are our and actually your interest also, because these help us to keep our prices there, where they are. If we start to manufacture and ship smaller quantity, both us and you will have way higher per piece cost and the business profit will be also so small, or nothing that finally it doesn't make sense to work for nothing (and that's right for both of us).

Dimethicone Products

An alternative on chemical products targeting fleas and ticks.

It's our answer on the easier and wider sales options, fields. In general there is no further registration needed as it's exempt from BPR (European biocide regulation).



This means, that you will not need further registration in your home country in general as we, the manufacturer have the exemption from the EU BPR on these products and as we, as our partners can sell these without further registration.

Our Dr. Peticon product line is a modern, non-biocide product, with high efficacy against fleas, ticks. We have right now collars and spot-ons for cats.

Dimethicone immobilizes fleas and ticks through purely physical means. Our Dr. Peticon product line does not contain chemical insecticides. Active ingredient is a special silicone oil (dimethicone) that forms a sticky layer around ticks, fleas. It acts like a trap that catches parasites.

Because of this, they will get paralyzed and will not be able to move anymore. The parasites will fall off of the animal or can be brushed off of it. The sticky effect takes place on a micro level and the coat will not be sticky.

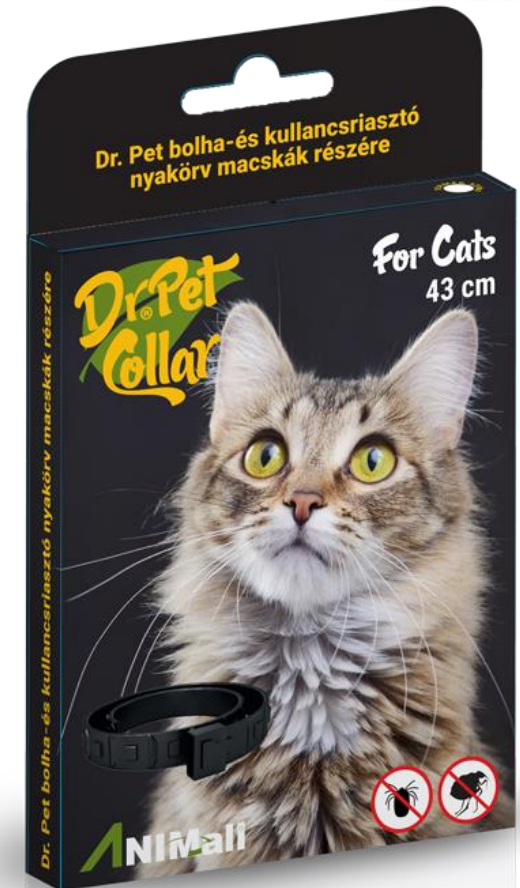

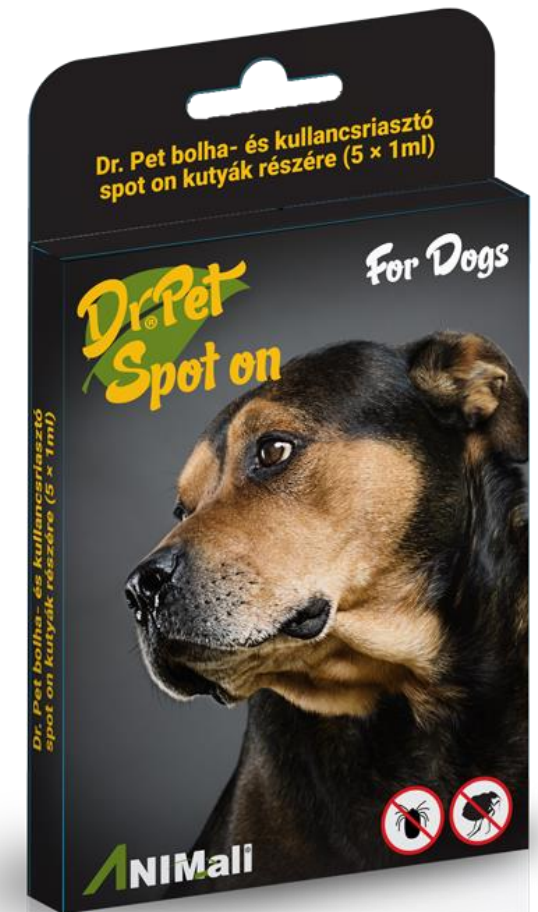
